Trailblazing Women in Sports Medicine

They came from basketball, lacrosse, and rowing. Softball, gymnastics, soccer, and track. Some of them always knew they wanted a career in sports medicine. Others followed the opportunities where they arose, ultimately choosing a field that has brought them tremendous professional and personal satisfaction. They have gone on to become physicians for professional sports teams, leaders in professional societies, specialists in the care of female athletes, researchers exploring gender inequities in orthopaedic care, and educators of the sports medicine professionals of the future. They are Hospital for Special Surgery's pioneering women of sports medicine, and they are transforming lives.

The First Center of Its Kind

HSS has a world-renowned reputation in sports medicine, one that expanded with the establishment of the Women's Sports Medicine Center in 1997 — the first of its kind. Today, the center offers comprehensive multidisciplinary care from orthopaedic surgery, primary care sports medicine, physiatry, physical therapy, nutrition, sports psychology, and performance to female athletes at all stages of life and with all abilities — from recreational to elite sports — in one location. Fellows, residents, and medical students rotating through the center learn about the range of issues that female athletes face and how to care for them. Some of the center's patients have gone on to pursue careers in medicine themselves.

When the Women's Sports Medicine Center began, not everyone at HSS understood why it was needed. "Some of them thought it was a marketing thing. They all took care of female athletes and didn't understand why we needed to do something different," explained

orthopaedic surgeon **Jo A. Hannafin, MD, PhD** (Fellow 1991 and 1992), who co-founded the center with **Lisa R. Callahan, MD,** a primary sports medicine physician. "But women were asking for something like this."

"Some of our colleagues questioned it and were asking, 'Are you saying we can't take care of women?" added Dr. Callahan. "But that wasn't it at all. Male providers can take care of female patients just as female providers can take care of male patients. But if you have an interest in your patient's problem or you're more of an expert in their problem, you can bring different options to the table. As people got educated about some of the specific challenges that female athletes faced, they started to recognize the value of having this center."

Key to the center's approach is the understanding that a sports injury is about more than a torn ACL or injured rotator cuff. For many athletes, especially those in high school or college sports,

being part of a team or engaging in a sport is a vital component of their identity. Female athletes are also less likely than their male counterparts to fully return to their sport after an injury. So when an injury sidelines them, their entire lifestyle changes. "Their lives are linked to that sport and to their teammates. Psychological problems, such as depression and anxiety, can happen as a result of not being a part of their sport during their recovery period," explained Dr. Hannafin. "Addressing these issues is an important part of getting athletes back to their sports, particularly for female patients. That's why we have a sports psychologist on our team."

Several HSS alumni who trained in the center are leading similar programs elsewhere. "Exposure to the HSS Women's Sports Medicine Center gave me a glimpse of what was possible in developing a new program for a specific patient population. It inspired me and gave me the confidence to build and work toward something that didn't exist in mainstream medicine," said **Miho J. Tanaka, MD, PhD** (Fellow 2012), who directs the Massachusetts General Women's Sports Medicine Program.

"At HSS, I was able to see so many successful sports medicine surgeons, each with their own approach to patient care and practice," added **Andrea M. Spiker, MD** (Fellow 2016 and 2017), Team Physician for the University of Wisconsin (UW) Badger Athletics and Director of the UW Hip Preservation Program. "I learned how to think critically, stay humble, put our patients first, and keep learning."

Since 2022, the HSS Women's Sports Medicine Center has been co-directed by **Marci A. Goolsby, MD,** and **Beth E. Shubin Stein, MD** (Fellow 2002). "Our goal is to be the premier women's sports medicine center, exemplifying the highest standards and quality of patient care while serving as a model for research, leadership, mentorship, and education," said Dr. Goolsby. "We are working to honor the legacy Dr. Hannafin and Dr. Callahan created through further advancement of the center's research, outreach, and educational opportunities."

"We want to bring information to as many people as we can about the resources we offer to treat female athletes, because one of the biggest issues is lack of information. If somebody doesn't know we're here, they're not going to find us," added Dr. Shubin Stein. "We've started an outreach campaign to connect online and in-person with all communities, but specifically underserved and marginalized communities that don't necessarily know that care is available to them. That's a major part of our mission."

Taking It to the Big Leagues

The list of female HSS sports medicine faculty and alumni who are or have served as physicians for collegiate and professional teams is an impressive roster. **Leigh Ann Curl, MD** (Fellow 1995), who played basketball for the University of Connecticut as an undergraduate, was the first female team orthopaedic surgeon in the National Football League and has served as head orthopaedic surgeon for the Baltimore Ravens since 1998. Watch a Ravens game and you are likely to see her on the sidelines.

"There were a lot of heads turned because it was not a normal thing to have a female physician on the field. But I grew up playing with boys. And my mentors in sports medicine were male," she said. "Now I don't even notice it because I've been doing it so long." She is also an assistant team physician for the Baltimore Orioles and has served as a team physician for the University of Maryland Terrapins, the New York Mets, USA Women's Basketball, USA Women's Rugby, and Johns Hopkins University and St. John's University athletics. Dr. Curl is now Chief of Orthopaedics at MedStar Harbor Hospital in Baltimore.

Kat McElheny, MD (Fellow 2018), who now practices in Vermont, served as a team physician for the New York Mets during the pandemic. "I was their infection control prevention coordinator and compliance officer, and as such, was responsible for oversight of all COVID-related issues and protocols during the 2020 season organization wide. I have never worked harder — as was the case for all medical personnel amidst this time — but while challenging, it was an unparalleled experience to be part of something so important and unknown. Baseball, and the energy that came from the ability to watch live sports from home, was very meaningful to this country during a difficult time."

Other HSS faculty and alumni who have served in leadership roles for elite and professional teams include:

- **Dr. Hannafin** (Fellow 1991 & 1992, HSS Faculty), who rowed at the national and international level, was a team physician for the U.S. Rowing Team and Olympic Rowing, the New York Mets, and the former WUSA New York Power women's soccer team. She and Dr. Callahan were team physicians for the New York Liberty for 15 years.
- **Dr. Callahan** (HSS Faculty) was the first female head team physician in the National Basketball Association and was Chief Medical Officer and Senior Vice President of Player Care at Madison Square Garden Sports, where she oversaw the care of professional teams including the New York Knicks, New York Rangers, New York Liberty, Westchester Knicks, and Hartford Wolf Pack. She was also a team physician for the men's and women's Olympic basketball teams, serving as the first female team physician for the men's team. Dr. Callahan was also a team physician for the New York Power, the New York Giants, and Olympic Gymnastics.
- Michelle G. Carlson, MD (Resident 1992, Fellow 1993, HSS Faculty) is the official second opinion physician in hand care for the NBA as well as consultant hand surgeon for several professional sports teams, including the New York Knicks, Brooklyn Nets, and New York Mets.
- Dr. Goolsby (HSS Faculty) has served as a physician at the Olympic Games with USA Biathlon and the US Olympic and Paralympic Committee, and was past team physician for the WNBA New York Liberty. She is currently the inaugural Director of Sports Medicine for the WNBA.
- Dr. Shubin Stein (Fellow 2002, HSS Faculty) was a former team physician for the U.S. Federation Cup tennis team and was assistant team physician for the New York Power.
- **Dr. Tanaka** (Fellow 2012) is the head team physician and medical director for the New England Revolution (MLS) and a team physician for the Boston Red Sox, Boston Glory ultimate frisbee team, and the Boston Ballet.
- Dr. Spiker (Fellow 2016 & 2017) and Molly A. Day, MD (Fellow 2021), are team physicians for University of Wisconsin Badger athletics.
- Ellen Casey, MD (HSS Faculty) is a former collegiate gymnast who is the USA Gymnastics Women's National Team Physician. She accompanied the team to the Paris Olympics this summer.

- Daphne A. Scott, MD (HSS Faculty) is the lead team physician for the New York Knicks and past team physician for USA Track and Field. She is also Head Consulting Orthopaedic Physician for the Ultimate Fighting Championship.
- Gabriella E. Ode, MD (Fellow 2019, HSS Faculty), Ashley V. Austin, MD (HSS Faculty), and A. Holly Johnson, MD (Resident 2006, Fellow 2007, HSS Faculty) are team physicians for the New York Liberty. Dr. Johnson is also Assistant Team Physician for the New York Rangers.
- Karen M. Sutton, MD (HSS Faculty), a former Division 1 lacrosse player for Duke University, previously served as Chief Medical Officer for World Lacrosse and is now Head Team Physician for USA Lacrosse. She is also team physician for U.S. Ski & Snowboard.
- Vonda Wright, MD (Fellow 2006), specializes in aging and sports and serves Division 1 football and Olympic athletes of Georgia State University, the University of Pittsburgh, the Pens Elite developmental hockey teams, World Rugby 7's and 10's, and Olympic Track and Field. She is also involved with elite masters athletes, players of the PGA tour championship and US Open, and dancers of the Atlanta and Pittsburgh ballet companies.
- Elizabeth R. Dennis, MD, MS (Fellow 2021), is a physician for the U.S. Open. She was a Division 1 collegiate softball player at College of the Holy Cross.
- Laura Moore, MD, PhD (Fellow 2023, HSS Faculty), is an associate team physician for the New York Mets, St. Lucie Mets, and Brooklyn Cyclones.
- Jacyln McKenna, MD (HSS Faculty), is head team physician for the Westchester Knicks.
- Samantha J. Stuek, MD (HSS Faculty), is team physician for U.S. Biathlon.

Stepping into National Leadership

Many female sports medicine surgeons and physicians who have practiced or trained at HSS have served in leadership positions of national orthopaedic and sports medicine organizations, often inspired by their HSS mentors. Dr. Hannafin, who was the first (and only) female President of the American Orthopaedic Society for Sports Medicine (AOSSM) from 2013 to 2014 and was inducted into the AOSSM Hall of Fame, makes a point of distinguishing between mentors and sponsors who help move your career forward.

"Mentors provide advice and guidance, while sponsors open doors," she explained. Renowned HSS sports medicine surgeon

Russell F. Warren, MD, served both roles for her as well as many other sports medicine trainees at HSS. "Russ Warren sponsored us in starting the Women's Sports Medicine Center by helping facilitate the creation of a formal space. He also opened doors for me at the AOSSM," she added. "I believe in giving back and opening doors for other women, whether it's a high school student who wants to rotate through the office for a week when she's on a school break or colleagues who need letters of recommendation."

In addition, Dr. Goolsby just finished a term as President of the American Medical Society for Sports Medicine (AMSSM). Dr. Shubin Stein is leading the publishing group of the AOSSM to promote the dissemination of reputable sports medicine information to healthcare professionals and the public. Dr. Sutton served on the American Academy of Orthopaedic Surgeons (AAOS) Board of Directors, AOSSM Research Committee, and American Shoulder and Elbow Surgeons Research Committee. HSS sports medicine surgeon Sabrina M. Strickland, MD (Resident 2001, Fellow 2002), serves on the Education and Surgical Skills Committees of the Arthroscopy Association of North America (AANA). Dr. Tanaka is on the AOSSM Board of Directors. Dr. Day and Dr. Dennis were accepted into the inaugural Boosting Orthopaedic Leadership Development (BOLD) Program with the AOSSM.

Others have led professional medical sports organizations. Dr. Callahan was a two-term President of the NBA Team Physicians

Association and Dr. Curl served as President of the NFL Physicians Society. Dr. Ode was an American Orthopaedic Association North American Traveling Fellow in 2022 — an honor considered a stepping stone to national leadership in the field. Fellows travel to 10 orthopaedic departments in one month, meeting with their chairs, giving lectures, and exchanging ideas related to leadership in orthopaedics. "Leadership can be different across different institutions. It was really a remarkable look behind the curtain and a life-changing experience," she asserted.

Closing the Gender Gap

Women have had opportunities to participate in more sports thanks to Title IX, but along with that comes an increase in injuries that are not always treated equitably. Dr. Ode noted that female athletes have been offered surgery at lower rates than males with the same injuries or later in the course of their condition, leading to worse outcomes. There has also been discordance in the way female and male surgeons communicate with female patients, with females who display emotions often being perceived as histrionic and possibly considered unable to tolerate a major surgery. A Canadian study showed that outcomes for female patients having surgery were worse if the surgeon was male versus female (JAMA Surg. 2022;157:146-156).

There may also be differences in the way females and males with pain are perceived by their healthcare providers: one study showed that among patients with chronic shoulder pain, men were more likely to receive analgesics while women were more likely to be prescribed psychotherapy. "This perpetuates the stereotype that women are irrational and hysterical and that their concerns are not valid," said Dr. Ode. "Ultimately that can breed mistrust in athletes because they feel like doctors are not understanding their concerns. Our goal is to get them back in the game."

Programs like the Women's Sports Medicine Center can help close the gaps in outcomes between women and men. "Providing optimal care for female athletes requires a multidisciplinary approach not just to treat their orthopaedic injuries, but also to address their nutritional, endocrine, metabolic, and psychological needs," said Dr. Dennis. "Gender-specific outcomes research will provide data to understand how to better care for all of our athletes. We know there are inherent differences in the physiology and anatomy of men and women that can affect not only their injury patterns, but their optimal surgical treatment and subsequent outcomes."

There has been a huge increase in ACL injuries among young athletes — partly due to sports specialization and playing one sport year-round, but also due to anatomical differences between men and women. The interface between cleats and turf surfaces may also be playing a role in ACL injuries. "One thing we're studying at HSS is the cleat-surface interface to see if a mismatch between footwear and turf increases the risk of an ACL injury," explained Dr. Sutton. "There are different turf fields and different types of turf filler. It can be very difficult to pick the right shoe."

One of the biggest reasons female athletes do not return to the field confidently after an ACL injury is because mentally, they're worried about another ACL injury. That's where the sports psychology offered by a women's sports medicine center can help. "Depression, burnout, anxiety, and disordered eating are all common in female athletes, which may not only increase an athlete's risk of injury but also interfere with their recovery following an injury. All sports medicine physicians need to be aware of the unique needs of female athletes and screen for emotional distress," said Dr. Day.

A Commitment to Research

The women of sports medicine who have worked or trained at HSS are committed to improving outcomes for all athletes through their research. Dr. Shubin Stein received a large grant from the AOSSM to lead a multicenter study on patellofemoral instability. The work of Dr. Dennis will also contribute to this study. Dr. Goolsby's research focuses on bone health in athletes and the female athlete triad. Dr. Hannafin maintained an active research program in ligament physiology for over 20 years and remains a collaborator and mentor.

Dr. Casey has published research related to the return to sport after pregnancy. "One of the most common concerns from female athletes is how to perform best throughout the different stages of their lifespan and the effects of changing hormones due to puberty, pregnancy, and menopause," she noted. She has published research on the effects of pregnancy on mental health, bone density, cardiovascular health, the pelvic floor, and the abdominal wall — including diastasis rectus abdominis (a widening between the rectus abdominis muscles and thinning of the linea alba that can happen during pregnancy).

Dr. Wright has reported research for 20 years on the effects of aging on musculoskeletal health. By studying more than 3,000 masters-level athletes participating in the National Senior Games, she and her co-investigators reported early on that sports performance could serve as a biomarker of aging. "Aging is not an excuse for abandoning mobility. If we are chronically active, it will save us from the ravages of chronic disease," she stated. The dramatic reduction in estrogen that accompanies menopause causes profound changes in the musculoskeletal system — what she has termed "musculoskeletal syndrome of menopause" — that can result in arthralgia that can be debilitating for one in four women who experience it. Yet often their doctors tell them they are just getting older and should live with it. "I feel like there's an opportunity for women in orthopaedics to step up and claim this area, because there's a lack of knowledge," Dr. Wright contended. "Saving mobility means saving lives."

Dr. Sutton received a grant to study female versus male knee ligament injuries related to lacrosse cleat-surface interface, which was presented to the International Olympic Committee. She is also comparing injuries between female and male elite and Olympic skiers.

Dr. Strickland is researching ways to replace cartilage more successfully and develop better techniques to treat patellar tracking problems and instability.

Dr. Spiker conducts research, serves as Associate Editor for the *American Journal of Sports Medicine*, and mentors medical students, residents, and fellows who are conducting research. "Just as there are fewer female surgeons than male surgeons in orthopaedic sports medicine, there are also fewer female surgeons and physicians performing research and acting on editorial boards," she contended. "I feel an obligation to give my time, effort, and dedication to advance research and take trainees through the challenges we encounter in research so they can navigate bumps in the road when they're on their own."

Educating Future Sports Medicine Physicians and Surgeons

Female sports medicine specialists at HSS also dedicate time to educating students of all ages, both female and male, who are interested in future careers in the field. Dr. Scott helps lead an 8-week summer program for undergraduate students who are

underrepresented in medicine and interested in orthopaedic surgery. They shadow HSS physicians and surgeons in their offices and operating rooms, attend lectures, go to different sporting events with team physicians, and receive guidance about resume building and interview skills. "Orthopaedic surgery is one of the least diverse fields," said Dr. Scott. "We stay in contact with these students for years, writing letters of recommendation and providing mentorship to help them get into medical school so they can continue on their path."

Several opportunities exist for students interested in women's sports medicine. The Ludwig Fellowship for Women's Sports Medicine Research is a 12-month clinical research fellowship that provides funding for an individual interested in medical and orthopaedic issues in women's sports medicine. In addition, with funding donated by Heartfelt Wings Foundation, the Women's Sports Medicine Center sponsors three female students in the following eight-week internships:

- A sports medicine internship for medical students who completed their first year of medical school.
- An internship addressing sports physical therapy, performance, and nutrition for a student who finished their junior year of college.
- A sports medicine internship for a pre-med student who completed their third year of college.

"What's astonishing is the number of young women who've gone through this program, became physical therapists and physicians, and started their own women's sports medicine centers," said Dr. Hannafin. "I took care of Dr. Kristin Hopkins when she was a collegiate field hockey athlete. She went on to do the summer internship, went to medical school, completed an orthopaedic surgery residency, and is now the director of the women's sports medicine center at Stony Brook University on Long Island."

One Word of Advice: Listen

Athletes of all ages today endure challenges off the field that can add to the stress they are feeling, affecting their risk of injury and their recovery after injury. Social media is a huge pressure for middle school and high school athletes in particular. "People tend to exaggerate what they're doing on social media. Other female athletes may see that and not just compete with themselves, but with the unrealistic goals of others," explained Dr. Sutton.

That's where being part of a sports team can be beneficial. "Girls are bombarded with images on social media that can make them feel like they're not like everyone else. Sports is a proving ground and a place where girls can connect on a different level," said Dr. Callahan. "I don't think I'd be where I am today without my background in sports."

Most of the women in sports medicine from HSS agreed the most common concern among female athletes is not being heard by their doctors. They gave one word of advice: listen. It's not unusual for female athletes who come to the Women's Sports Medicine Center to report feeling dismissed by their other doctors and not feeling

truly heard until they arrived at HSS. "The presentations of female athletes are not always going to be the same as male athletes with regard to musculoskeletal dysfunction, pain, or injury," said Dr. Spiker. "There are certain aspects of a female athlete's nutrition, outside pressure on her appearance, hormonal fluctuations due to menstrual cycles, or higher prevalence of joint hypermobility that male athletes simply don't have to deal with."

"I think it's really important, whether you have a female athlete or a male athlete, to take the time to listen to them," asserted Dr. Hannafin. "You have to really talk to athletes and understand what their goals are and what they're willing to do to get back to their goals."

The trailblazing HSS women in sports medicine feel grateful for the careers they have chosen. "Those of us who do sports medicine are really blessed," concluded Dr. Hannafin. "We care for healthy, motivated people of all ages who want to continue having an active lifestyle that's going to benefit them for their entire lives. It's really a wonderful life."

A **FORUM** for Women in Orthopaedics

Several women in sports medicine who practice or trained at HSS are members of FORUM, a national group of board-certified fellowshiptrained female orthopaedic surgeons who specialize in sports medicine. Remembering Paul M. Pellicci, MD

Paul M. Pellicci, MD, passed away on November 21, 2023. A graduate of Johns Hopkins University and Cornell University Medical College, Dr. Pellicci completed residency at New York Hospital, Cornell Medical Center/Hospital for Special Surgery and his fellowship at Brigham and Women's Hospital, Harvard.

He returned to HSS, where he served as an attending surgeon until his retirement in 2019. During his time at HSS, Dr. Pellicci was Chief of the Hip Service from 1993 until 2005 and served in several other leadership roles during his career. He received the Philip D. Wilson Jr., MD, Teaching Award in 1996 and 2005. In 2018, Dr. Pellicci was honored at the HSS Gala with the Lifetime Achievement Award.

Dr. Pellicci was one of the youngest surgeons ever to be admitted to the prestigious Hip Society and over his career he authored or co-authored nearly one hundred articles in peer-reviewed journals and wrote numerous textbook chapters and instructional manuals. His research interests involved complete anatomic restoration of the soft tissue structures following total hip replacement. Dr. Pellicci was a mentor and inspiration to countless young surgeons, shaping the future of orthopaedic surgery. Colleagues remember him not only for his medical expertise but also for his compassion and dedication to patient care and unwavering support of the residents and fellows.

On behalf of the entire HSS community we extend our condolences to Dr. Pellicci's family and other loved ones.

A Tribute to Gregory E. Lutz, MD

Fellow 1993 and HSS Staff



Gregory E. Lutz, MD

Gregory E. Lutz, MD, a beloved caregiver to thousands of patients and a friend, mentor, and inspiration to many colleagues, passed away on March 5, 2024, after a courageous battle with cancer. He was 61 years old. As founder of the Physiatry Department at HSS, Dr. Lutz was one of the world's leading experts in regenerative sports medicine.

Dr. Lutz was born in Camden, NJ, to Dr. Elmar Gregor Lutz and Barbara Jane Donnelly. He enjoyed sports from an early age, competing in basketball and bodybuilding, ultimately winning Mr. Teenage New Jersey. In 1984, Dr. Lutz graduated magna cum laude and Phi Beta Kappa from Drew University, where he met the love of his life, Paula Gibson. Dr. Lutz graduated from Georgetown University School of Medicine in 1988 and was awarded the Dr. Margaret M. Kenrick Achievement Award for Excellence in Physical Medicine & Rehabilitation. He went on to pursue his specialty training in Physical Medicine & Rehabilitation at the Mayo Clinic, before completing an Orthopaedic Sports Medicine Fellowship at HSS in 1993.

Dr. Lutz became the first Physiatrist-in-Chief at HSS in 1997 and was a Professor of Clinical Rehabilitation Medicine at Weill Cornell Medical College. Under his 15-year leadership, the department grew to become one of the largest outpatient musculoskeletal practices in the world. He also established the Spine & Sports Medicine Fellowship, mentored more than 60 fellows, and was the Founder and Medical Director of the Regenerative SportsCare Institute (RSI+) in Manhattan. As a former Assistant Team Physician for the New York Mets and a Consulting Physician to the NHL's Players Association, he successfully treated professional athletes in the NBA, NFL, MLB, NHL, and ATP, in addition to business leaders, entertainers, and elite athletes of all kinds.

He was a trailblazer in intradiscal biologic injections and the nonsurgical management of spine and joint injuries. Dr. Lutz pioneered novel approaches to the treatment of degenerative disc disease and other musculoskeletal disorders, using regenerative procedures to successfully

treat many injuries previously considered incurable. In 2004, he received the PASSOR (Physiatric Association for Spine Sports and Occupational Rehabilitation)
Research Award, given to one physiatrist annually who has demonstrated excellence in musculoskeletal research.

His relentless pursuit to go above and beyond for his patients is a testament to the man he was — a devoted husband, father, grandfather, son, brother, physician, mentor, and friend. Patient care and spending time with his family and friends were his greatest passions. When not seeing patients, one would find him lifting weights, skiing, golfing, or walking in the woods with his dog, Theo. Dr. Lutz is survived by his loving wife, Paula; his three adult children, Anna (Paul), Cole (Tracey), and Olivia; his grandson, Kuno Gregor; and siblings, Mary Bernadette, Michael, and Christopher (Fellow 2001). James P. Smith, MD

James P. Smith Jr., MD, died peacefully at his home in Interlaken, NJ, on March 25, 2024, at the age of 94. Raised in Asbury Park, NJ, he received his undergraduate and medical degrees from Georgetown University in Washington, DC, and did his internship and residency training at what was then New York Hospital-Cornell Medical Center and completed a fellowship in pulmonary disease at Cornell University Medical College.

Following the construction of the Berlin Wall, Dr. Smith served as a Captain and Assistant Chief of Medicine in the U.S. Army, 79th Engineer Battalion, in Pirmasens, Germany. During his tour, he took part in Operation Home Run (November 1963–February 1964) assisting the victims of a devasting earthquake in Skopje, former Yugoslavia. He also met Elizabeth Julia Fink, his future bride, and the love of his life, who was teaching the children of U.S. Army personnel at the American School. They were engaged in St. Moritz, married in Minnesota in 1964, and moved to Manhattan.

Dr. Smith was an Attending Physician at NewYork-Presbyterian Hospital and Hospital for Special Surgery. In 1975, he established a scoliosis pulmonary laboratory at HSS that later merged with the EKG Lab to become the hospital's Cardiopulmonary Laboratory.

His groundbreaking career in medicine spanned more than half a century. He was a pioneer in the treatment of tuberculosis and of chronic obstructive pulmonary disease and was a founder of the International Early Lung Cancer Action Project, which spearheaded the use of low radiation dose chest CT for lung cancer screening. He was also one of the first physicians to recognize liver toxicity from certain TB medications and founded one of the first pulmonary intensive care units in the country, leading to the widespread use of mechanical ventilators.

A Clinical Professor of Medicine at Weill Cornell Medical College, he gave back generously to the medical community as a teacher and mentor to generations of young doctors, through his work as Secretary of the American Lung Association and the American Thoracic Society and President of the New York Lung Association, and through five decades of clinical practice in Manhattan.

In private practice, Dr. Smith was the personal physician to Manhattan socialites, professional athletes, stars of stage and screen, and even kings, but always made time for anyone — family, friends, or friends of friends — who came to him seeking his medical wisdom, guidance, or help. He was perennially named one of the best doctors in America but was most humbled by the awards he received for "bedside manner." Anyone who had the privilege to know him, whether professionally or personally, understands how well he merited this recognition. Apart from his family, friends, and medicine, his great loves were deep sea fishing and the New York Football Giants.

Dr. Smith was predeceased by his beloved wife, Elizabeth, and his daughter, Stephanie. He is survived by his children, Susan Smith Mitchell (Douglas), James P. Smith III (Kathleen), and Patricia Smith Barrett (Daniel), as well as 10 adoring grandchildren, his sister Janet Carton (James D.), and many nieces, nephews, and cousins.

Emerald S.K. Lin, MD

Dr. Emerald S.K. Lin, an accomplished Physical Medicine and Rehabilitation physician who specialized in treating traumatic brain injury, passed away on February 8, 2024, in New York City. She was a vibrant, compassionate doctor and mother who had a profound impact on many and will be deeply missed.

Emerald Sianchin Kwai Lin was born on October 16, 1980, in Camden, New Jersey. She grew up in Mount Laurel, New Jersey, and graduated from Lenape High School in 1999. She went on to graduate from Brandeis University in 2003 with double bachelor's degrees in biology and neuroscience, then earned her Doctor of Medicine from Rutgers Robert Wood Johnson Medical School in 2008.

Dr. Lin completed her residency training in Physical Medicine and Rehabilitation at the Icahn School of Medicine at Mount Sinai in 2012, followed by a fellowship and board certification in traumatic brain injury at the Kessler Institute for Rehabilitation in 2013. During this time, she quickly emerged as a national leader in her specialty, elected by her peers in the Association of Academic Physiatrists (AAP).

From 2013 to 2015, Dr. Lin served as medical director and as a traumatic brain injury specialist at Fort Belvoir Community Hospital in Virginia, where she thrived and helped countless veterans. Following that, she joined Hospital for Special Surgery, serving as Director of Residency Education for the Department of Physiatry.


Dr. Lin radiated warmth, compassion, and kindness in her interactions with her patients, colleagues, and most of all, her mentees. She loved caring for her patients and helping them heal. Dr. Lin was respected for her clinical acumen, passion for teaching, and contribution to medical research in traumatic brain injury.
